- The appointment is purely on temporary and may be terminated at any time by giv 1(one) month notice without assigning any reason thereof. If he / she wants to resign, he she may do so after giving 1(one) month notice or by surrendering 1(one) month salary. (iii)
- The regularization of service shall be considered on completion of probationary per. subject to satisfactory performance of duty in his/her initial place of posting. (iv)
- After joining duty, he / she will have to take an oath of allegiance of affirmation to (v)
- He / she will have to produce Medical Fitness Certificate from an authorized Medi (vi)
- The appointment is Subject to the Police Verification and he / she will dismissed for government service if any adverse report is there with immediate effect.
