ORDER

Shri/Miss/Mrs Midi Darang is hereby engaged as Part Time Teacher on contract basis in the fixed pay of Rs,5000/- (Rupees Five thousand) only per month with effect from the date of joining in the concerned school up to 31<sup>st</sup> March, 2018 under the Central Sponsored Scheme of Sarva Siksha Abhiyan. He/ She is posted at Residential School Depi,

The engagement is subject to the following conditions:-

1. The contract FTT/PTT and Supporting staff has no right to claim for regular appointment/regularisation of the post after expiry of contract engagement.
2. No Earned Leave is permissible except 12 (twelve) days casual leave and 2 (two) days R.H as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
3. During contract service period he/ she is not entitle for medical reimbursement, winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.
4. The contract FTT/PTT/Supporting staffs have to report his/ her duty at posting place within 07 (Seven) days from the date of issues of this order failing which his/ her engagement order will automatically be treated as cancelled. The actual date of joining report should be submitted through proper channel (HT, BEO, and DDSE cum DPO).
5. He/ She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of services.
6. No representation will be accepted for change of posting place.
7. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced from time to time.
8. The engaged FTT/PTT and Supporting staff has to sign as agreement for contract engagement before receiving this engagement order.
9. The extension of the contract period will be subject to the salary approval from MHRD and performance report from the school authority.
10. The contract staffs engaged is posted to the school against which he/she has applied and interviewed for and is non-transferable.
11. Payment of salary shall be made on receipt of the performance report of the incumbent.
