ORDER

Teacher on contract basis up to 31.03.2007 in the fixed pay of Rs. 7200/- (Rs. Seven Thousand Two Hundred) only with effect from the date of Joining in the Govt. Primary School, Medo Tea Garden against the centrally sponsored scheme of SSA.

The engagement is subject to the following conditions.
