Hr. Sec. School, Deomali, Tirap District Arunachal Pradesh.

The appointment is made against Shri. Yiken Basar, JT, Promoted to HM (non-plan) post.

The appointment shall be on probation for a period of 2(two) years w.e.f. the date of joining. Her continuation beyond probation period for 2(two) years shall be subject to satisfactory performance during probation period.

The appointment is subject to the following conditions:-

1. The appointment is purely temporary and may be terminated at any time by giving 1(one) month notice. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering one month salary.

6. The seniority of the appointee shall be based strictly on merit list.
