Miss Lily Yirang, is hereby appointed temporarily to officiate as Junior Teacher [Social Studies] in the PB-2 of Rs. 9300-34800 + GP Rs. 4600/- PM plus other allowances as admissible under rules from time to time with effect from the date he actually reports for duty to the Principal, Govt. Hr. Sec., School, Mebo, East Siang District Arunachal Pradesh.

The appointment is made against Chow Saong Mounkang JT V/ Retired (non-plan) post.

The appointment shall be on probation for a period of 2(two) years w.e.f. the date of joining. Her continuation beyond probation period for 2(two) years shall be subject to satisfactory performance during probation period.

The appointment is subject to the following conditions:-

1. The appointment is purely temporary and may be terminated at any time by giving 1(one) month notice. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering one month salary.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.


