// **APPOINTMENT ORDER** //

He is posted at GSS, Manmow.

**The Engagement is subject to the following term & conditions:-**

1. The contract employee has no right to claim for regular appointment/regularisation of the post after expiry of contract engagement.
2. No earned leave is permissible except 8 days casual leave as per Employment Contract Civil Service Leave Rule.
3. The mark sheets/certificates submitted by his/her for consideration are subject to verification from original source. In case of the forged mark sheets/certificates, he/she is liable to face legal action as per CCS Rule.
4. During contract service period he/she is not entitled for medical reimbursement, allowances, children education allowances, reimbursement of tuition of self & dependent, concession (LTC), special compensatory allowances etc.
5. The engaged employee is also to work as volunteer instructor for the interests of children of Namsai District in Arunachal Pradesh in addition to his/her normal duties. Further, he engaged is also bound to perform any other duty assigned by the District Collector, District Administrator/Education Department in any addition to his/her normal duties.
6. The contractor employee have to report for his/her duty at posting within 7 (seven) days, failing which his/her appointment order will automatically be treated as cancelled.
7. He/she is not entitled to subscribe GPF/CGEIS/CPS etc. during the period of contractual services.
8. No representation will be accepted for change of posting place.
9. The other terms and conditions of service which are not specified shall be governed by the relevant rules/orders/guidelines/instruction in force time to time.
10. The engaged employee has to sign an agreement for contractual engagement after receiving this appointment order.
11. His/her contractual service will remain valid for 01 (one) year and thereafter it will be treated automatically terminated and a fresh renewal will be required.


