**The Engagement is subject to the following term & conditions:-**

1. The contract employee has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
2. No earned leave is permissible except 8 days casual leave as per Temporary Central Civil Service Leave Rule.
3. The mark sheets/certificates submitted by his/her for consideration are subject to verification from original source. In case of the forged mark sheets/certificates, he/she is liable to face legal action as per CCS Rule.
4. During contract service period he/she is not entitled for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.
5. The engaged employee is also to work as volunteer instructor for the interest of literacy of Namsai District in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt. /Dist. Administrator/Education Department in any addition to his/her normal duties.
