In pursuance of Govt. approval vide U.O. No. Nil Dated 03/03/2008 the service of Nang. Humkham Pomoung is hereby regularized temporarily to officiate as Assistant Teacher(A) in the Scale of Pay of Rs.4500-125-7000 p.m. plus other allowances as admissible under Rules from time-to-time w.e.f. she actually reports for duty to the DDSE, Tezu, Lohit District, Arunachal Pradesh. He/She is posted under disposal of DDSE, Tezu. He/She is appointed against Shri. Pem Despa AT(A) retired.

- p) The appointment is subject to the Police Verification and He/She will be dismissed from Govt. service if any adverse report is there with immediate effect
