Shri Mohd. Lutfi is hereby engaged as Junior Teacher (Social Studies) on contract basis in the fixed pay Rs. 16,435/- (Rupees Twenty six thousand four hundred fifty three) only with effect from the date of joining up to the academic session 2013-14 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He is posted at Govt. Residential School, Neta.

This engagement is subject to the following conditions:

- (i) The contract teacher has no right or status for regular appointment/regularization of the post after expiry of contract engagement.
- (ii) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement only.
- (iii) During contract service period he/she is not entitle for professional enhancement, winter allowances, children education allowance or reimbursement of tuition fees, leave travel concession etc. as specified in departmental circulars and orders.
- (iv) The second party shall be entitled for draw of salary of only for the actual days worked. Salaries for vacation period shall be drawn only when they are engaged in the camp, night course and any other departmental engagements.
- (v) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the UDSE, failing which his/her engagements order will automatically be treated as cancelled.
- (vi) He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- (vii) The engaged teacher is also to work as Volunteer Instructor for SBM programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- (viii) His/her appointment will be accepted for change of posting place.
- (ix) He/She will have to undergo DIET training at concerned DIET for training as and when called for.
- (x) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- (xi) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
