ORDER

Shri Mani Lallam is hereby engaged as Junior Teacher (Social Studies) on contract basis at the fixed pay Rs. 26,433/- (Twenty six thousand four hundred fifty three) only with effect from the date of joining up to the academic session 2013-16 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He is posted at Govt. Residential School, Nere.

The engagement is subject to the following conditions:

- a) The contract teacher has no right or status for regular appointment/regularization of the post after expiry of contract engagement.
- b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement letter.
- c) During contract service period he/she is not entitled for gratuity, reimbursement, winter allowances, labor concession allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory, contract etc.
- d) The second party shall be entitled for drawal salary of only for the contract period. Salaries for vacation period shall be drawn only when they are engaged in the regular job/course and any other departmental engagements.
- e) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- f) He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- g) The engaged teacher is also to work as Volunteer Instructor for SBM programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- h) His appointment will be accepted for change of posting place.
- i) He/She will have to undergo DIET training at concerned DIET for training as and when call for.
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force at the time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
