- h) He/She will have to under gone DIET training at concern DIET for Training and when call for.
- i) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced from time to time.
- j) The appointed teacher has to sign an agreement for contract appointment before receiving this appointment order.


