ORDER

In pursuance of the Govt. approval, Shri/Smt. Abhishek Kumar Mishra, is hereby appointed temporarily as Primary Teacher on Compassionate ground in the Pay Matrix of PB-2-9300-34800 +GP-4200/- per month plus other allowances as admissible under rules from time to time with effect from the date he/she actually reports for duty, his posted at the disposal of DDSE Shi Yomi District.

The appointment shall be on Compassionate Ground as Govt. of India, Ministry of Home Affairs Order No. 1404/20/90 Estt. (D) dated 09/12/93.

The appointment is made against the vacant post of Shri A.R. Das (Promoted).

The appointment is made subject to the following conditions:-

1. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
2. The appointment is subject to Police Verification and he/she will be dismissed from service if any adverse reports is found against him/her with immediate effect.
3. After joining duty he/she will have to take oath of allegiance of affirmation to the Constitution of India in the prescribed form.
4. On joining, the appointee shall have to serve for a minimum period of 03 (three) years at the place of posting.
5. The appointment order shall be cancelled if the appointee directly or indirectly campaign for charge of posting place or does not join within 15 (fifteen) days from the date of issue of this order at posting place.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
