ORDER

In pursuance of administrative approval No.SS-11303/3/2021 dated 5th Jan/2022, the newly recruited Ms. Khommi Changmi is hereby engaged as Part Time Instructor(PTI) on contract basis in the fixed pay Rs. 12,809/- (Rupees Twelve thousand Eight hundred Nine) only per month with effect from the date of joining in the school against Centrally Sponsored Scheme of Samagra Shiksha Society/ISSE. She is temporary engaged at GSS Namphai-1.

The engagement is subject to the following conditions:-

- The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract appointment.
- No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- During contract services period he is not entitle for medical reimbursement , winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowances etc.
- The contract teacher have to report his duty at posting place within 7(seven) days from the date of joining in the office of the DDSE, failing which his engagement order will be automatically be treated as cancelled.
- He is not entitle to subscribed GPF or CGEIS or other schemes during the period of contract services.
- No representation will be accepted for changing of posting place.
- The employee has to sign an agreement for contract engagement before receiving this engagement order.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and orders in forced time to time.
- The contract service shall be terminated by the undersigned on receipt of substantive complaint.
