## ORDER

Shri Gida Taya is hereby promoted to Junior Teacher on contract basis in the fixed pay of Rs. 26,453/- (Rupees Twenty Six Thousand Four Hundred Fifty Three) only for 10 (Ten) months upto 31st March'2018 with effect from the date of joining in the Institution under Sponsored Scheme of Sarva Shiksha Abhiyan against Smti Ome Tamin, JT (SSA) resigned. Further extension of service is subject to satisfactory performance of his duty.

The engagement is subject to the following conditions: -

- 1. The Contract Teacher has no right to claim for regular appointment/regularization of the post after
- 2. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- 3. If the incumbent remain absent, no Pay will be paid for the absent periods.
- 4. In case, the appointee is found not staying in his /her place of posting and not sincere in his/her duty, his/her Contract Service will be terminated at any time by the SSA District Mission.

- 11. No representation will be accepted for change of posting place.
- 12. He/She will have to under go DIET training at concern DIET for training as and when call for.

- 13. The engaged teacher has to sign an agreement for contract engagement before becowing this engagement order.
- 14. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time as per Central Civil Services (Temporary Services) Rules 1965.
