ORDER.

In pursuance of the Govt. Approval Vide U.O.No.Nil Dated 3rd May'2011, Miss. Pumima Borang is hereby regularized temporarily as Junior Teacher in the Pay Band-2-9300-34800 + GP-4600/- p.m. plus other allowances as admissible under Rules from time to time with effect from the date he/she actually report for duty to the concerned DDSE, Pasighat, Distt. East Siang. The appointment is made against Shri. P. Jayaraman, J/T Promtd. to V/P.

The appointment shall be on probation for a period of 2 (two) years w.e.f the date of joining. His / her continuation beyond probation period for 2 (two) years shall be subject to the satisfactorily performance during probation period.

The appointment is made subject to the following conditions:-

- a) The appointment is on probation for a period of 2(two) years. During probationary period, his/her services may be terminated at any time without any notice or assigning any reason. The regularization of service will be considered on completion of probationary period subject to satisfactory performance of duty.
- b) After joining duty, he/ she will have to take on Oath of allegiance of affirmation to the constitution of India in prescribed form.
- c) He / she will have to produce Medical fitness certificate from an authorized Medical Officer.
- d) The appointment is subject to the Police verification and she will be dismissed from service, if any adverse report is there with immediate effect.
- e) On their appointment as a Junior Teacher they should undergo compulsory in-service DPEB.Ed. within 3 (three) years failing which their appointment order shall be cancelled.

The other terms and conditions which are not specified herein shall be governed by the relevant in force from time to time.


