- 2) The incumbent will have no right to claim for regular appointment as ADEO/APO as the post is not promotional post but interchangeable.



is hereby appointed as JP (Regular) on contract basis in the consolidated Salary of Rs. 6,500/- (Rupees six thousand five hundred only with effect from the date he/she actually report for duty to Leporiang Middle School under disposal of DDSE Papumpare dist. The appointment is made for the period of 2(two) months.

The contract appointee have to report his/her duty at posting place within 07(seven) days from the date of issue of this order, failing which his/her appointment will automatically be treated as cancelled.

The appointment is subject to the following conditions :-

- a) The contract appointee has got no right to claim for regular appointment/regularisation on expiry of contract service.
- b) The appointment of contract basis is purely temporary and appointee is liable to be terminated at any time without assigning any reason or notice thereof.
- c) The contract appointee shall have to report for his/her duty in the posting place within 7(seven) days positively.
- d) During contract service period, his services is not transferable.
- e) No Earned leave is permissible except Casual leave as per C.C.S. Rule.
- f) The other terms and condition of the service which are not specified in the agreement shall be governed by the relevant rules and order inforce from time to time.
