ORDER

She is posted at Govt. Primary School, Innao Singpho

The appointment is subject to the following conditions: -

1. The contract service has no right to claim for regular appointment/regularization of the post after expiry of contract appointment.
2. No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
3. During contract service period she/he is not entitle for medical reimbursement, winter allowance, children education allowance, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowance, etc.
4. The contract service have to report his/her duty at posting place within 7(seven) days failing which his/her engagement order will be automatically be treated as cancelled.
5. She/he is not entitled to subscribe GPF or CGEIS or other schemes during the period of contract services.
6. No representation will be accepted for changing of posting.
7. The other terms and conditions of services which are not specified shall be governed by the relevant rules and orders in forced time to time.
8. She/he has to sign an agreement for contract before receiving this engagement order.
9. The contract service shall be terminated by the undersigned on receipt of substantive complaint from the concerned DDSE/DC of the district
