Mdl. School, Pacha.

The engagement is subject to the following conditions: -

 a) The contract Teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.

b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.

c) During contract service period he/she is not entitle for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.

d) The second party shall be emitted for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge Course and any other departmental engagement.

The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the DDSE, failing which his/her engagement order will automatically be treated as cancelled.
