ORDER

Ms. Pralibha Yadav is hereby engaged as Assistant Teacher (Hindi medium) on contract basis in the fixed pay Rs. 21,175/- (Rupees: Twenty one thousand one hundred seventeen/- only) only with effect from the date of joining up to the academic session 2012-13 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. She is posted at Govt. P. S. School (Donyi Putang).

The engagement is subject to the following conditions:

- a) The contract Teacher has no right to claim his regular appointment regularization of the post after expiry of contract engagement.
- b) No earned leave is permissible except casual leave as per Central Govt. Service Leave Rule and as per terms and condition mentioned in the aforesaid order.
- c) During contract service period he/she is not entitle for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.
- d) The second party shall be entitled for drawn salary of only for the nineteen session. Salaries for vacation period shall be drawn only when they are engaged in training, Lodge Course and any other departmental engagement.
- e) The contract teacher have to report to her duty at posting place within 7 (seven) days from the date of joining in the office of the DESE. Failing which her engagement order will automatically be treated as cancelled.
- f) He/She is not entitled to subscribe GPF or CGPS or such other schemes during the period of contract services.
- g) The engaged teacher is also to work as Volunteer Instructor for Adult Education programme & other education related programmes for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- h) No representation will be accepted for change of posting place.
- i) He/She will have to undergo DLL-I training & complete DLL-I for training as and when call for.
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
