Miss Dasaya Yobin is hereby engaged as **Part Time Instructor (Work Education)** on Contractual basis against the vacant post Miao Block, under the disposal of DDSE-cum-DPO, Changlang at a fixed salary of Rs 12,809/- (Rupees Twelve Thousand Eight Hundred Nine) only per month for a period of 6 (six) months w.e.f the date of joining.
