He/She is posted at 100 Girls Res. School, Yomcha.

The appointment is made subject to the following terms & conditions:-

1. The contractual appointment has no right to claim for regular appointment/regularization of the post after expiry of contract period.
2. No earned leave is permissible except casual leave as per Central Civil Service leave rule and as per terms and condition mentioned in the agreement copy.
3. During contract service period he/she is not entitle for medical reimbursement winter allowances (LTC), special compensatory allowance except fixed pay of Rs. .... per month.
4. The appointee has to report his/her duty at concerned posting place within 7(seven) days from the date of issue of this appointment order, failing which his/her appointment order will automatically be treated as cancelled.
5. He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
6. No representation will be accepted for change of posting place.
7. The other terms and conditions of services which are not specified here in shall be governed by the relevant rules and order in forced from time to time.
8. The appointee on contract basis has to sign an agreement for contractual appointment at the time of receiving his/her appointment order copy.
