- The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy. » b)
- During contract service period he/she is not entitle for medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; c) leave travel concession (LTC); special compensatory allowances etc.
- The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which d) his/her engagement order will automatically be treated as cancelled.
