- 1. The services of the employed on contract basis will be placed at the disposal of Dy. Director of School Education, in the District (where he/ she is interviewed and selected) Changlang.... of Arunachal Pradesh without any other choice of the candidate.
- 2. This contract service shall be for the academic session ... 2017-18commencing from the date of joining in the place of posting and ending at the end of the academic session (at the end of the annual examination.)
- 3. The second party should be ready to serve in any Govt. Primary / Upper Primary Schools including those located in remote interior area where strenuous journey on foot is required. In case of refusal the appointment order will be treated as cancelled.
- 4. i) The second party shall have no right to claim for regularization of the services rendered on contract basis. The period of service rendered on contract basis shall not be counted for any other purposes too.
 - ii) The second party, in the event of his/ her getting barred by age for any other employment during the currency of the contract services shall not claim for regular appointment in the post now offered to him / her on the contractual basis.
- 5. i) The second party will be entitled for the consolidate fixed pay of Rs. 12809/- (Rupees twelve thousand eight hundred nine) only per month as mentioned in the order during the period of contract.
 - ii) Dearness Allowances :- No dearness allowances or any other allowances will be paid to the second party during the period of contract service.
 - iii) TA & Daily allowances :- The second party will be entitled to TA/ DA for the period of absence from headquarters on official duties supported by Govt.orders as per rules applicable to other regular Govt. employees.
 - iv) TA & DA at the time of appearing in the interview and for joining in the service is not permissible.
 - v) The second party will not be entitled to joining time pay. In fact the service of the second party will be counted from the date of joining in the institution for purpose of his pay.
