In pursuance of the DPI, Govt. of Arunachal Pradesh, Naharlagun letter No. ED-2/147/90 Pt/4060 dated 7/11/92 Sri/Smt/ Miss Sojum Talyan is hereby provisionally appointed as A/T(4) in the scale pay of Rs.1200-30-1560-EB-40/-PM plus other allowances as admissible under the rules from time to time and posted to Govt. Middle School/Pry School Talangam with effect from the date on which he/she reports for duty in his posting place.

The appointment is subject to the following condition:-

- a) The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one months notice from either side.
 - b) After joining duty he/she will have to take an oath of allegiance or give affirmation to the constitution of India in the prescribed form.
 - c) He/she will have to produce a medical Certificate from an authorised Medical officer to the effect that he/she is medically fit for the Government Service.
 - d) He/She will give an undertaking to the effect that he/she will serve anywhere in Lohit District and the tenure at the first place of posting will not be less than three years.
3. The appointment is subject to the police verification and he/she will be discharged from the service with immediate effect if there is any adverse remarks against him/her in the police report.
