- h) No representation will be accepted for change of posting place
- i) He/She will have to undergone DIET training at concern DIET for training as and when call for.
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time
- k) The engaged teacher has to sign an agreement for contract engagement before receiving to his engagement order.
