ORDER

Gyamar Melu is hereby engaged as Assistant Teacher on contract basis in the fixed pay of Rs.7200/- (Rupees Seven Thousand Two Hundred) only with effect from the date of joining in the concerned district upto.2010 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He/She is posted at Govt. Primary/Upper Primary School,

The engagement is made vice resignation/expire/not joining of Shri/Smti/Miss...., A/T (SSA).

The engagement is subject to the following conditions: -

- 1. The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- 2. No Earned Leave is permissible except casual leave as per Central Civil Service Leave
 Rule and as per terms and condition mentioned in the agreement copy.
- 3. During contract service period he/she is not entitle for Medical Reimbursement, Winter Allowance, Children Educational Allowance, Reimbursement of Tuition Fees, Leave Travel Concession (LTC), Special Compensatory Allowance etc.
- 4. The Second Part shall be entitled for drawal salary of only for the academic session.

 Salaries for vacation period shall be drawn only when they are engaged in training,

 Bridge Course and any other departmental engagement.
- 5. The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- 6. He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.

- 7. The engaged teacher is also to work volunteer instructor for TLC programmes for the interest of literacy in Arunachal Pradesh in addition to the normal duties.
- 8. No representation will be accepted for charge of posting place.
- 9. He/She will have to under gone DIET training at concern DIET for training as and when call for.
- 10. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- 11. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
