3. During contract service period he/she is not entitle for Medical Reimbursement, Winter Allowance, Children Educational Allowance, Reimbursement of Tuition Fees, Leave Travel Concession (LTC), Special Compensatory Allowance etc.

4. The Second Part shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training,
