ORDER

In the interest of the public service following candidates are hereby appointed provisionally to facilitate as Assistant Teacher Grade 'A' in the scale of pay of 4500-125-7000/- p.m. plus other allowances as admissible from time to time w.e.f. the date he/she actually reports for duty at their posting places (schools) as shown against their names.

This appointment is subject to the approval of the Director of School Education, A.P., Naharlagun and on the following terms and conditions:

- (i) The appointment is purely temporary and may be terminated at any time without assigning any reasons after one month notice. If he/she wants to resign may require to give one month notice or surrender one month salary.
- (ii) He/She will have to produce Medical Fitness Certificate in prescribed form issued either by the DMO/CMO/Civil Surgeon and should be submitted in their posting places alongwith Joining Report
- (iii) Joining will be accepted from the date he/she actually reports for duty at their posting places.
- (iv) After joining in duty he/she shall have to take on Oath of allegiance of affirmation to the Constitution of India in the prescribed form
- (v) The appointment is subject to Police Verification and he/she will be dismissed from Govt. Service if any adverse report are there with immediate effect.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.

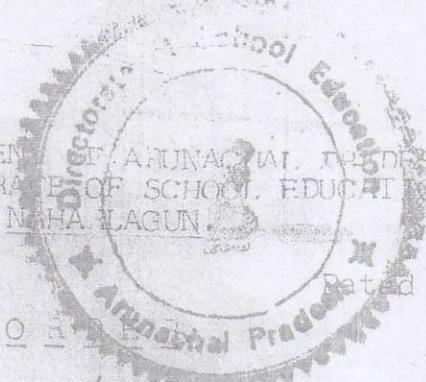

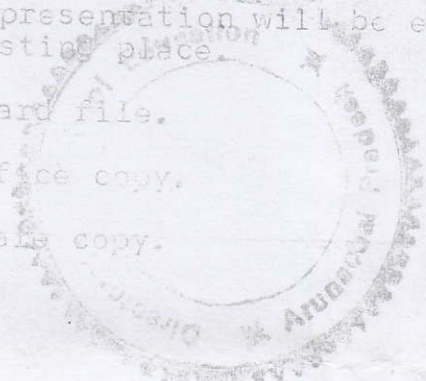
