f) He/ she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.

g) The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/ her normal duties.

h) No representation will be accepted for change of posting place.
