- During contract service period he/she is not entitle for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowance etc.
- The contract teacher have to report his/her duty at posting place within 7(seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order ~~is automatically he treated as cancelled~~
- He/she is not entitled to subscribed GPF or CGBIS or such other schemes during the period of contract services.
