ORDER

Miss Nipi Yomcha is hereby appointed as Full Time Teacher on purely contract basis in the fixed pay of 20000/- (Rupees Twenty thousand only) for the period of six months with effect from the date of joining in the concerned posting place against centrally sponsored scheme of **Sarva Shiksha Abhiyan**, created against the residential schools.

She is appointed in place of **Shri Binjum Sora** and posted at **Govt. 100 Girls Residential School, Yomcha.**

The appointment is made subject to the following terms and conditions -

- 1 The engagement is a purely temporary basis and may be terminated from service anytime without assigning any causes/notice considering his/her performance of service.
- 2 The contractual appointment has no right to claim for regular appointment/regularization of the post after expiry of contractual period.
- 3 No earned leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
- 4 During contract service period he/she is not entitle for medical reimbursement, winter allowances (LTC), special compensatory allowance except fixed pay of Rs. 20000/- per month.
- 5 The appointee has to report his/her duty at concerned posting place within 7(seven) days from the date of issue of this appointment order, failing which his/her appointment order will automatically be treated as canceled.
- 6 He/she is not entitled to subscribe GPF or DGEIS or such other schemes during the period of contract services.
- 7 No representation will be accepted for change of posting place.
- 8 The other terms and condition of service which are not specified here in shall be govern by the relevant rules and order in forced from time to time.
- 9 The appointee on contract basis has to sign an agreement for contractual appointment at the time of receiving his/her appointment order copy.
