## **ORDER**

- 7. No representation will be accepted for change of posting place.
- 8. He/she will have to undergo DIET training at concern DIET for training as and when call for.
- The other terms and condition of services which are not specified shall be governed by the relevant rules and order in force from time to time.
- 10. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
