d) The contract teacher have to report his/ her duty at posting place within 10 (ten) days from the date of joining in the office of the concerned DDSE cum DPO, failing which his / her engagement order will automatically be treated as cancelled.

e) He/She is not entitles to subscribe GPF or CGEIS or such other schemes during the period of contract services.

f) The engaged teacher is also to work as volunteer instructor for TLC programmed for the interest of literacy in Arunachal Pradesh in addition to his / her normal duties.

g) No representation will be accepted for change of posting place.
