## ORDER

Miss Nangram Meenu is hereby promuoted to Juntor Tracker from Assistant leacher on contract basis in the fixed pay of Rs. 26,453/- (Respects Twenty Six Thousand Four Hundred Fifty Three) only with effect from the date of joining in the concerned district upto 2013 against Centrally Sponsored Scheme of Sarva Shiksha Abbayan. He/She is temporarily posted at Govt. LV Primary/Upper Primary/Sec./Hr.Sec. School, old Banks under & plose ang. Circle.

## The engagement is subject to the following commissions:

- The Contract Teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- If the insumbers remain absent, no Pay will be paid for the absent periods.
- 4. In case, the appointee is found not staying in his /her place of posting and not sincere in his/her duty, his/her Contract Service will be terminated at any time by the SSA District Miscion.
- 5. At the end of the contract Agreement, the incumbent shall have to again enter into fresh contract for the next academic period.
- 6. During contract service period he/she is not entitle for Medical Reimbursement, Winter Allowance, Children Educational Allowance, Reimbursement of Tuition Pees, Leave Travel Concession (LTC), Special Compensatory Allowance etc.
