ORDER

Shri Robin Kodak is hereby appointed to officiate as PRT in the scale of pay Matrix Level-6, Cell-1 of Rs 35400/- per month plus other allowances as admissible under rules from time to time with effect from the date he/she actually reports for duty to the DDSE Daporijo and posted under the disposal of DDSE Daporijo.

1. The appointment is made against Shri Tamar Riba, PRT (Retired).
2. The incumbent shall be on probation for a period of 2 (two years) with effect from the date of joining. His/her continuation in service beyond probation period of two years is subjected to satisfactory performance during probation period.
3. The appointment is subjected to the following conditions:-
 - a) The appointment is purely temporary and may be terminated at any time without assigning any reason after serving one month notice. If he/she wants to resign may require to give one month salary.
 - b) After joining in the duty he/she shall have to take an oath allegiance of affirmation to the constitution of India in the prescribe form.
 - c) He / She will have to produce medical fitness certificate in prescribed form from an authorized medical officer.
 - d) The appointment is subjected to police verification and he / she will be dismissed from Govt. services if any adverse reports are there with immediate effect.
 - e) The appointment Order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 15 (fifteen) days from the date of issue of this Order.
4. The others terms and conditions of services which are not specified herein shall be govern by the relevant rules and order in force from time to time.
