ORDER

Ms. Tsering Lamu is hereby engaged as TGT (Hindi/Secondary Level) on contract basis in the fixed pay Rs. 25,000/- (Rupees Twenty Five thousand) only with effect from the date of joining up to the financial year 2022-23 i.e. 31-03-2023 against Centrally Sponsored Scheme of Samagra Shiksha (ISS) of Sec. Mrs. Gyamar Ashna, not joined. She is posted to Govt. Sec. School, Pabua.

The engagement is subject to the following conditions:-

- a) The contract Teacher has no right to claim for regular appointment regularization of the post after expiry of contract engagement.
- b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions of the contract.
- c) During contract service period he/she shall be entitled to medical reimbursement, winter allowances, children education allowances, telephone charges, station fees, leave travel concession (LTC), special compensatory allowance, etc.
- d) The second party shall be entitled for draw salary for the period he/she are engaged in training. Salaries for vacation period shall be drawn as per normal rules.
- e) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the DDSE/DPD, which his/her engagement order will automatically be treated as cancelled.
- f) He/She is not entitled to subscribed CPD, COEIS or any other schemes during the period of contract services.
- g) The engaged teacher is also to work as Volunteer Inspector for Adult Education programme & other educational related programmes for the promotion of literacy in Arunachal Pradesh in addition to his/her normal duties.
- h) No representation will be accepted for change of posting/assignment.
He/She will have to undergo DDSE training at concerned place for training as and when call for.
The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force from time to time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
