The appointment is subject to the following conditions:-

- Their contractual service is purely temporary and can be considered for continuation on the basis of performance and approval of salary in subsequent PAB.
- 2. They have no right to claim for regular appointment / regularization of the post after expiry of contract
- 3. They have to submit RCI Registration number to the office of the State Project Director, SSA Rajya Mission, Itanagar within 3 month from the date of appointment, failing which their appointment will be treated as cancelled
