**//APPOINTMENT ORDER//**

Sniti Padmamoni Bhardinara is hereby engaged as Part Time Instructor (Art Education) on contractual basis against Govt. Upper Primary School, Ampongne under the office of the District Project Officer, SSA, Kurung Kumey District at fixed pay of Rs. 12,809/- (Rupees Twelve Thousand Eight Hundred Nine) only per month upto 31<sup>st</sup> March'2018 and further appointees shall get their salaries only after its approval from MHRD, Govt. of India.

The appointment is subject to the following terms and conditions:-

1. The contract employee has no right to claim for regular appointment/regularization of the post after expiry.
2. No Earned Leave is permissible except casual leave as per Central Civil Service Leave rule and as per terms and condition mentioned in the agreement copy.
3. During contract service period he/she is not entitle for Medical Reimbursement, Reimbursement of Tuition fees, Leave travel concession (LTC), Special compensatory Allowance etc.
4. The contract employee have to report for his/her duties at the place of posting within 7 (Seven) days failing which his/her employment order will automatically be treated as cancelled.
5. His/her service period will be counted from the date of joining in the duties.
6. He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
7. No representation will be accepted for change of posting place or service extension.
8. If he/she is found to be not sincere or irregularity to discharge his/her duties, the authority is deem fit to cancelled or terminate to the post unconditionally.
9. The employee has to sign an agreement for contract engagement before receiving this order.
