LAPPOINTMENT ORDER//

Miss Tadar Mejum is hereby appointed as Part Time Instructor (Art Education) on contractual basis against Govt. Upper Primary School, Sangram Town under the office of the District Project Officer, SSA, Kurung Kumey District at fixed pay of Rs. 12,809/- (Rupees Twelve Thousand Eight Hundred Nine) only per month against the vacancy of Miss Tai Yash (PTI Resigned). Further, the appointees shall get their salaries only after its approval from MHRD, Govt. of India.

The appointment is subject to the following terms and conditions:-

- right to claim for regular has no employee 1. The contract appointment/regularization of the post after expiry.
- 2. No Earned Leave is permissible except casual leave as per Central Civil Service Leave rule and as per terms and condition mentioned in the agreement copy.
- 3. During contract service period he/she is not entitle for Medical Reimbursement, Reimbursement of Tuition fees, Leave travel concession (LTC), Special compensatory Allowance etc.
- 4. The contract employee have to report for his/her duties at the place of posting within 15 (fifteen) days failing which his/her employment order will automatically be treated as cancelled.
- 5. His/her service period will be counted from the date of joining in the duties.
- 6. He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- 7. No representation will be accepted for change of posting place or service
- 8. If he/she is found to be insincere or irregularity to discharge his/her duties, the authority is deem fit to cancelled or terminate to the post unconditionally.
- The employee has to sign an agreement for contract engagement before receiving this order.

10. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time by the appointing authority.
