He is posted at Govt. Pry. School, Pania Sollung and temporarily attached at Govt. Mdl. School, T/Warrang.

The engagement is subject to the following conditions: -

a) The contract Teacher has no right to claim for regular appointment/regularization of the post

b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.

e) During contract service period he/she is not entitle for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel

d) The second party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge Course and

e) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the DDSE, failing which his/her engagement order will

f) He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period

g) The engaged teacher is also to work as Volunteer Instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.

h) No representation will be accepted for change of posting place.

i) He/She will have to undergone DIET training at concern DIET for training as and when call
