## //APPOINTMENT ORDER//

Shri Tolum Pinku is hereby engaged as PRT on contractual basis at the fixed pay of Rs, 15,000/-(Rupees Fifteen Thousand) only per month, with effect from the date of joining in the district against Centrally Sponsored Scheme of Samagra Shiksha (ISSE). - 2. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- 3. If the incumbent remain absent, no pay will be paid for the absent period.
- 4. In case, the appointee is found not staying in his/her place of posting and not sincere in his/her duty, his/her contract service will be terminated at any time by the DPD, ISSE Kurung Kumey.
- 5. At the end of the contract agreement, the incumbent shall have to again enter into fresh contract for the next academic period.
