O R D E R

Shri Nando Taku (B.A History Hons.) is hereby appointed / engaged as a (J/T) on Contractual basis against the Pakke Kessang KGBV, Sarva Shiksha Abhiyan Mission East Kameng District at fixed salary/ Honorarium of Rs. 8,500/- (Eight Thousand Five Hundred) only per month for a period of 1 years w.e.f. date of joining. Further extension of his/her engagement period will be subject to his/her satisfactory performance.

The engagement is subject to the following conditions:-

- a) The contract teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- c) During contract service period he/she is not entitle for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowances etc.
- d) The Second party shall be entitled for drawl salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement.
- e) The contract teacher have to report his duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- f) He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- g) The engaged teacher is also to work as volunteer instructor for TLC programmed for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- h) No representation will be accepted for change of posting place.
- i) He/She will have to undergo DIET training at concern DIET for Training as and when call for.
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced from time to time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- l) The contract service shall be terminated by the undersigned on receipt of substantive complaint from the concerned NGO/ DDSE/ DC of the district.
- m) He/She should obtain professional training Certificate of B.ed through distance mode from IGNOU or any recognized institute at his/her own cost within the period of three years from the date of appointment. Failure to obtain the same shall entail termination from the contractual service without prior notice.
