ORDER

Miss Chukhu Mesum is hereby engaged as 'Assistant Teacher' (AT) on contract basis under SSA program in the fixed pay of Rs. 21175/- (Rupees Twenty One Thousand One Hundred Seventy Five) only with effect from date on which he/she joins in the school of concerned block/circle.

The appointment is made against the resultant vacancy arose due to resignation of Miss Chukhu Yoyu A/T (SSA) of Govt. Primary School Upper Tago. He/she is posted at Govt. Primary School Upper Tago under Ziro-II Block of Lower Subansiri District.

The engagement is subjected to the following conditions:-

1. The contract Teacher has no right to claim for regular appointment/regularization of the post after expiry of contract appointment
2. No earned leave is permissible except casual leave as per Central Civil Service leave Rule as per terms and condition mentioned in the agreement copy.
3. During contract service period, he/she is not entitle for medical reimbursement, Winter allowances, Children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), Special Compensatory allowances etc.
4. The second party can be entitled for drawal salary of only for the academic session. Salary for vacation period shall be drawn only when they are engaged in training, bridge courses and any other departmental engagement.
5. The contract teachers have to report his/her duty at posting place within 7(Seven) days from the date of issue of this order failing which his/her engagement order will automatically be treated as cancelled.
6. He/she is not entitled to subscribe GPF or CGIES or such other schemes during the period of contract services.
7. The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
8. No representation will be accepted for change of posting place.
9. He/she will have to undergo DIET training at Yachuli when call for DIET training at Yachuli.
10. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
11. The engaged teacher has to sign an agreement for contract engagement before receiving this appointment order.
