c) During contract service period he/she is not entitle for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc

d) The second party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training. Bridge Course and

any other departmental engagement

e) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the DDSE, failing which his/her engagement order will automatically be treated as cancelled

He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period

g) The engaged teacher is also to work as Volunteer Instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.

h) No representation will be accepted for change of posting place. i) He/She will have to undergone DIET training at concern DIET for training as and when call

relevant rules and order in forced time to time. k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
