- c) During contract service period he/she is not entitle for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowance etc
- d) The contract teacher have to report his/her duty at posting place within 7(seven) days from the date of joining in the office of the concerned DDSE cum DPO, failing which his/her engagement order will automatically be treated as canceled.
- e) _____ is not entitled to subscribe NGS or CGEIS or such other schemes during the period of contract services.
- f) The engaged teacher is also to work as volunteer instructor for TIC programmed for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- g) No representation will be accepted for change of posting place.
- h) He/She will have to undergo DIET training at concern DIET for training and when called for.
- i) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
