

## ORDER

On the basis of SSA Teacher walk-in-Interview held from 11<sup>th</sup> September to 14<sup>th</sup> September'2010, Shri/Smti./Miss **Deena Samnam (Bengia)** is hereby engaged as **Junior Teacher** on contract basis in the fixed pay of **Rs. 8500/- (Rupees Eight Thousand Five Hundred)** only with effect from the date of joining in the concerned school upto end of Academic session 2010-11 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He/She is posted at Govt. Primary/Upper Primary/Sec. School, **Chambang** under Chambang Circle in Kurung Kumey district.

The engagement is subject to the following conditions: -

- 1. As per the terms and conditions of the advertisement 'only the candidates who are willing to stay and serve in the interior locations of Kurung Kumey district may apply'. Therefore, the appointee shall have to join his/her place of posting without any delay. If the candidates fail to join the place of posting within 7 days, this appointment order stand automatically cancelled.
- 2. Also, on the ground of above terms and conditions, no representation for change of place of posting shall be entertained by the SSA District Mission.
- 3. In case, the appointee is found not staying in his/her place of posting, and not sincere in his/her duty, his/her Contract Service will be terminated at any time by the SSA District Mission.
- 4. If the incumbent remain absent, no Pay will be paid for the absent periods.
- 5. At the end of the contract Agreement, the incumbent shall have to again enter into fresh contract for the next academic period.
- 6. The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- 7. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- 8. During contract service period he/she is not entitle for Medical Reimbursement, Winter Allowance, Children Educational Allowance, Reimbursement of Tuition Fees, Leave Travel Concession (LTC), Special Compensatory Allowance etc.
- 9. The Second Party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge Course and any other departmental engagement.
- 10. He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- 11. The engaged teacher is also to work volunteer instructor for TLC programmes for the interest of literacy in Arunachal Pradesh in addition to the normal duties.
- 12. No representation will be accepted for charge of posting place.
- 13. He/She will have to under gone DIET training at concern DIET for training as and when call for.



- 14. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- 15. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
