Govt. of Arunachal Pradesh, in East Kameng District in anticipation of final appointment order from the Directorate of Public Instruction, Naharlagun in the scale of pay of RS:1200-30-1560-EB-40-2040/- pm plus other allowances admissible under rules from time to time from the date on which he/~~xxxx~~ actually reports for duty to the ~~xxxxxxxxxxxxxxxxxxxx~~/Teacher-in-charge. He/~~xxx~~ is posted to Sario-Saria IV school with immediate effect.

The appointment is subject to the following conditions:-

1. The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one month's notice from either side.
2. After joining duty he/~~xxx~~ will have to take an oath of allegiance to give affirmation to the Constitution of India duly in the prescribed form.
3. He/~~xxx~~ will have to produce a Medical Certificate from an authorised Medical Officer to the effect that he/~~xxx~~ is medically fit for the Government service.
4. The appointment is subject to the Police verification and he/~~xxx~~ will be discharged from the service with immediate effect if there is any adverse remarks against him/~~xxx~~ in the police report.

The other terms and conditions which are not specified herein would be governed by the rules and orders that may be in force from time to time and the undertaking given by him/~~xxx~~. **No change of place of posting will be considered as per undertaking furnished.**
