ORDER

Miss Yayak Kion is hereby engaged as Trained Graduate Teacher(Maths & Science) on contract basis in the fixed pay Rs.20,000/- (Rupees Twenty Thousand) only with effect from the date of joining up to the academic session 2020-21 against Centrally Sponsored Scheme of Integrate Scheme of School Education. She is posted at Govt. Middle School, Dipik.

The engagement is subject to the following conditions:-

- a.) The contract Teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b.) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditioned mentioned in the agreement copy.
- c.) During the contract service period he/she is not entitle for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowances etc
- d.) The second party shall be entitled for drawal salary of only for the academic session. Salaries for vacation periods shall be drawn only when they are engaged in training, bridge course and other departmental engagement.
- e.) The contract Teacher have to report his/her duty posting place within 7 days from the date of joining in the office of the DDSE-cum-DPO, ISSE/SS failing his/her engagement order will automatically be treated as cancelled
- f.) He/She is not entitled to subscribed GPS or CGEIS or such others scheme during the periods of contract service
- g.) The Engaged teacher is also to work as volunteer Instructor for Padhna Likhna Abhiyan Programme for the interest of Literacy in Arunachal Pradesh in additional to his normal duties
- h.)No representation will be accepted for change of posting place
- i.) He/She will have to undergo DIET training at concerned DIET for training as and when call for.
- j.) The others terms and conditions of service which are not specified shall be govern by the relevance rules and order enforce time to time.
- k.) The engaged teacher has to signed an Agreement for contract engagement before receiving this engagement order


