**ORDER**

On the Basis of the Recommendation of the Departmental Promotion Committee held on 21.06.2021. The following Integrated Scheme for School Education TGT (ISSE) Teachers are hereby regularized as Trained-Graduate Teacher (TGT) from 01.08.2021 in the Pay Matrix Level-7, Cell-1, PB-2 Plus other allowances as admissible under rules from time to time he or she reports for duty to the Office of the Deputy Director of School Education – Lemmi, Pakke Kessang District as shown below:-

The appointment shall be on probation for a period of 2 (two) years with effect from 01/08/2021. His/Her continuation beyond probation period for 2 (two) years shall be subject to satisfactory performance during probation period.

This issued with the Approval of Govt. Vide U.O. No. HM(EDN)-12/2021/400, Dated 05/08/2021.

**The Appointment is subject to the following conditions:-**

1. The Appointment is purely temporary and may be terminated at any time by giving 1(one) month notice. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering one month salary.
2. The regularization of service will be considered on completion of probationary period subject to satisfactory performance of duty.
3. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
4. The appointment is subject to Police verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
5. After joining duty he/she will have to take Oath of an allegiance of affirmation to the Constitution of India in the prescribed form.
6. On joining, the appointee shall have to serve for a minimum period of 3 (Three) years at the place of posting.
7. The seniority of the appointee shall be based strictly on their date of joining.
8. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 15 (fifteen) days from the date of issue of this order at his/her posting place and copy of joining report be submitted to this Directorate through DDSE concerned.
9. On their appointment as Trained-Graduate Teacher (TGT) they should undergo compulsory in-service course of DPE/B.Ed/D.El.Ed within 3 (three) years failing which their appointment order shall be cancelled.

The other terms and condition of service which are not specified herein shall be governed by the rules in force from time to time.
