ORDER

Shri Ranka Dodum is hereby engaged as Assistant Teacher on contract basis in the fixed pay Rs. 21,175/- (Rupees Twenty one thousand one hundred seventy five) only with effect from the date of joining in the district up to the academic session 2012-13 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan vice Shri Dishu Notung, A/T resigned as per SPD, Itanagar's approval order No.AR/SSA/Appointment-II/2011-12/109 dtd. 11/4/2012. He is posted at Govt. Pry. School, Rikung.

The engagement is subject to the following conditions: -

- a) The contract Teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- c) During contract service period he/she is not entitle for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.
- d) The second party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge Course and any other departmental engagement.
- e) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- f) He/She is not entitled to subscribed GPF or CGEIS of such other schemes during the period of contract services.
- g) The engaged teacher is also to work as Volunteer Instructor for SBM programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- h) No representation will be accepted for change of posting place.
- i) He/She will have to undergone DIET training at concern DIET for training as and when call for.
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
